

## List of Organizations Potentially Subject to Carbon Market in Carbon Pollution Accountability Act

Entities subject to carbon charges under the Carbon Pollution Accountability Act will be required to buy allowances if their emissions have exceeded 25,000 metric tons of CO<sub>2</sub>e ([carbon dioxide equivalent](#)) annually at least once in the prior three years. Not all entities that appear on the current list are subject to the Carbon Pollution Accountability Act, and others not listed could be required to pay the carbon charge.

The list below shows entities with emissions that exceed 25,000 metric tons of CO<sub>2</sub>e annually but does not indicate which ones will be required to pay carbon charges.
